As can be seen, local employers are giving our Pearls opportunity to restore their lives with employment. Wings of God is not just a house, it is a spiritual hospital. We celebrated Pearls baptisms as well as visits to churches where they shared their testimonies and the benefits of living at Wings of God. Each day we witness "Ah Hah" moments with the Pearls as God reveals a truth to them in a life changing way.
